

### WFNL UNDER AGE APPLICATION

INDEMNIFICATION FORM SENIOR NETBALL

#### MINIMUM AGE REQUIRMENTS

WFNL has a minimum age in all divisions that a player must turn at least 15 years of age one month prior to the year of competition in which the player seeks to register. The minimum age requirement is in place for the best interests of the league and to ensure the safety of all competing players and a positive competition experience for all players. Any team that plays a player under this minimum age will be deemed to have played an ineligible player and the match will be forfeited and the club liable to a fine, by reading and reviewing this paperwork any child under the age of 15 the same year of competition the parents are agreeing to allow their child to take the court and to be under the supervision on the WFNL Club and League while participating within our competition for the season.

#### UNDER 15 - WFNL INDEMNIDICATION FORM REQUIRMENT

The Parent or Guardian of a player who is 14 years of age at the commencement of the season must complete this Indemnification form and sign in the presence of the Netball Operations Coordinator.

#### PARENTS AND PLAYERS SHOULD BE AWARE THAT:

- Under 15 players will be consistently exposed to older and physically stronger athletes.
- Under 15 players will often be traveling, training and playing in an adult environment.
- The Parent and Player are aware that the WFNL is a senior competition.

#### **INDEMNIFICATION AGREEANCE:**

The Western Football Netball League (WFNL), that oversees the Belgravia Apparel Netball competition, and the league member club named herein, I hereby indemnify and hold harmless the aforementioned entities, including their representatives, from any and all suits, actions, demands, or proceedings arising from any injury, incident, event, or happening that may occur as a result of my child's involvement in the WFNL competition. This includes, but is not limited to, any injury or incident related to my child's participation in playing or being involved with the team, which is attributable to the fact that my child is under 15 years of age. I acknowledge the league's policy allowing juniors (those turning 14 or older in the year of competition) to participate and have discussed with the club the specific circumstances under which my child will be playing, training, and traveling. I understand and accept the potential for greater risk of injury due to my child participating in a senior competition and, notwithstanding this, I consent to my child's involvement. I accept that the club will take reasonable and appropriate steps to ensure my child is not involved in anything that will cause my child any ill will or injury. I fully understand that all responsibility for my child's safety and well-being, including their travel, training, playing, and involvement with the team, remains with me as the parent or guardian, and I will take all necessary precautions to ensure my child's safety.
